

WP2 Permanent Governance for the ERIC Forum

- Regular revision of the Rules of procedure according to WP 2 schedule
- Major topic: further shaping of the election process for Chair and Vice Chair
- Confirmation of the general approach: MoU and Rules of procedure





Rules of procedure What's new?

- Election of Chair and Vice-Chair process
 - EB sets up election committee
 - Chair and Vice-Chair are elected separately
 - Duration of Chairmanship changed:
 - 2 years +1 year (instead of 1+1+1....)
 - Expression of mistrust (2/3 Majority)



Rules of procedure What's new? Tendencies

More diversity in the ERIC Forum!

- As a general principle: "The ERIC Forum supports and will facilitate diversity in its governing and other bodies."
- Specifically: composition of **Executive Board** "With the permission of the legal representative of one ERIC, senior staff members can also run for this office."

More balance between the Clusters!

- Composition of **Executive Board** "If the number of ERICs in cluster exceeds 25% of the total number of ERICs, an additional Executive Board member can be nominated."
- While representing the Forum, the effective and balanced representation of all clusters must be taken into account by the Chair.



Rules of procedure What's new? Tendencies

More transparency/ information/ participation:

- General Assembly meeting:
 - **Purpose**: defining the programs and strategies and to deliberate on organizational and main issues (...)
 - relevant documents as basis for decisions must be sent around well in advance;
 - EC, ESFRI and national Ministries as permanent observers;
 - Structure: Open Forum with internal part.

Chair

- represents the Forum towards external institutions, based on the positions, which have been defined within the Forum.
- shall report back to the Forum.

Executive Board

- shall circulate in advance to all members the agenda of its meetings,
- informs the Forum Assembly in an adequate manner at least every three months about ongoing activities.





























Why have you adopted KPIs?

- To have an internal management tool that helps the ERICs to achieve tangible results, and enables
 the monitoring of progress against set objectives, mission, and vision;
- To document improvements and developments, and monitor performance in various areas of interest, including e.g. scientific outcomes and outputs, technical performance, operations, adequacy of services, access, trainings, user uptake etc.;
- To have an instrument for communicating the successes of the ERICs to various audiences and stakeholder groups by presenting measurable results;
- To improve the long-term impact and value of the ERICs, demonstrate their effectiveness, efficiency
 and accountability, and address the requests of governing bodies;
- To mitigate risks by detecting problems early on, and provide informed feedback on key strategic documents and policies of the ERICs;
- In case of distributed ERICs, to better evaluate the work of headquarters and measure the level of engagement with each national node.













How often do you report to your stakeholders on the status of your KPIs?





On a scale from 1 (not difficult) to 10 (difficult), how difficult is it for your RI to track and report on KPIs?








WP6 Forward Looking Taskforce (FLTF)

As per the ERIC Forum workplan, the annual science policy reports are selected, drafted and disseminated by a "Forward Looking Task Force" (FLTF) within WP6.

All ERIC Forum beneficiaries have been invited to join the FLTF, on a voluntary basis, through email consultation.

The WP6 FLTF is composed of representatives from 22 partner ERICs and associated organizations.





WP6 Selection topics of policy briefs

Methodology: In order to identify the priorities for the ERIC Forum policy briefs and seminars, a preliminary list of relevant policy topics was proposed and discussed at the kick-off meeting. Additional topics were added following consultations and discussions. A shortlist was then created by the Task Leader with the topics that could be of relevance to all partners.



The shortlist was sent to the FLTF and votes were collected on each topic through email discussions and teleconferences.

This methodology was used to select the topics of all the policy briefs with 1 vote per participating ERIC.

The drafted policy reports contribute to prepare the ERIC Forum seminars, are further discussed during the seminars and then finalized and disseminated by the FLTF.

Funding models for access to ERIC multinational & IC transnational services: Key recommendations

ERICs should be fully eligible and be recognized by national funding agencies, and cross-border funding from national funding agencies should be promoted;

ERICs and funding bodies at all levels can join efforts to improve ERICs visibility and attractiveness. Funding bodies should actively refer applicants to ERICs, encouraging and providing incentives for their use;

Transnational Access mechanisms must be safeguarded, and expanded to support ERIC consolidation, respond to specific challenges, develop research communities and provide a flexible budget for sustainable access for competitive projects;

Simplification of the application and financial processes for distributed RIs in Horizon funding can help to overcome bureaucratic hurdles and boost the visibility of ERICs;

Dialogue and collaboration among national, regional and European funding bodies must be strengthened to ensure the alignment of strategies and the synergic use of resources.

Funding models for access to ERIC multinational / transnational services: Key recommendations

Over the course of the past decade, European Research Infrastructure Consortia (ERICs) have become key instruments for cutting-edge science that provide solutions to today's major socio-economic and environmental challenges, underpinning the development of the European Research Area (ERA) and fostering multinational and transnational cooperation. Funding from diverse schemes, together with the invaluable contributions of ERIC member countries, have allowed ERICs to deliver access to services, facilities, samples and data across Europe. With the future of the ERA at our doorstep, ERICs must continue to evolve and expand their outreach, while upholding the highest standards of scientific excellence. Funding schemes that can sustainably provide resources in sufficient volumes will be essential.

As funding mechanisms evolve, the following

- ERICs should be fully eligible and be recognize by national funding agencies, and cross-border funding from national funding agencies should be promoted;
- ERICs and funding bodies at all levels can join efforts to improve ERICs visibility and attractiveness. Funding bodies should actively refer applicants to ERICs, encouraging and providing incentives for their use;
- Transnational Access mechanisms must be safeguarded, and expanded to support ERIC consolidation, respond to specific challenged develop research communities and provide flexible budget for sustainable access for competitive projects;
- Simplification of the application and financial processes for distributed RIs in Horizon funding can help to overcome bureaucratic hurdles and boost the visibility of FRICs:
- boost the visibility of ERICs;
 Dialogue and collaboration among national, regional and European funding bodies must be strengthened to ensure the alignment of strategies and the synergic use of resources.

A continuous and open dialogue between ERICs and all funding bodies is required to identify and adopt solutions that will lead to the optimized and sustained use of ERICs. A dedicated working group will be created within the ERIC Forum to continue exploring these questions and reflect on pragmatic solutions.

The collaboration between the El Commission and the Member States in the continued evolution of the ERIC Regulation, is also required to define and optimise the funding volume and mechanism supporting the broad variety of ERIC operations models, sustained effort from ERICs in the evaluation and assessment of the funding models will contribute to fruitful and productive dialogue.

The ERIC Forum, through its dedicated working group and through all of its members, will continue to play an active role in improving the visibility of ERICs and in maintaining an open and sustainable dialogue with the European Commission, with ESFRI, and with the national public funding bodies. It will strive to contribute to the international recognition and the competitive edge of European Research Infrastructure landscape, strengthening Europe's global position in research and innovation, and improving the life of European citizens.

Creating synergies between ERICs and the (Regional) Research and Innovation Strategies for Smart Specialisation -RIS₃: Key recommendations

ERICs have a high impact in Regions as catalysts of economic growth, high-quality employment and trans-national cooperation.

Regional Smart Specialization Strategies are a pre-requisite for a region to leverage ERDF funds.

ERICs must become aware of RIS3 to understand how and where they can add value real benefit to their local stakeholders.

ERICs should seek for ERDF funds to help the development of the RIS3.

The interest and use of this synergistic approach are not new (examples of Greece, Italy, etc.).

Spain is the first Member State that has launched a specific call for projects to maximize this synergy, with Andalucia to be the Region case-study. This can be used as Best Practice.

A coordinating Bureau should be established in order to promote and implement a framework to multiply and channel ERICs efforts to this direction.
